## Booking - Terms and Conditions

### Booking Form

Bookings will only be accepted from adults over the age of 25 who in signing the booking form accept the conditions on behalf of the party members. Bookings will not be accepted from groups aged 25 or under.

### Deposit

A 25% deposit is required upon booking. This is NON-refundable.

### Confirmation

A booking will only be deemed confirmed after receipt of the booking form and deposit after which E-Mail confirmation will be issued.

### Payment

The balance of the holiday cost together with the breakage/damage deposit of £200 is payable no later than eight weeks prior to the holiday start date. Where a balance remains unpaid after the date due has elapsed we reserve the right to cancel the booking.

### Amendments and Special Requests

Amendments and special requests must be notified to us in writing and subject to approval.

### Cancellation

Cancellations must be made in writing by the person in whose name the booking has been made. The following Cancellation Charges will be apply:

Eight weeks prior to holiday start date – Loss of Deposit

Six weeks prior to holiday start date – Total holiday cost unless subsequently re-let

### Letting Conditions

- Keys will be available from 4pm on start day and property must be vacated by 10am on the finish day. **Note:** Failing to vacate the property may result in the guests being liable to pay any expenses for the incoming guests, which may include accommodation charges.
- The maximum sleeping capacity must not exceed the booking agreement.
- Any changes to the booking, including the names and size of the party, as specified on the booking form must be agreed and confirmed in writing in advance.
- The owners will make every effort to repair without delay any defect in/or breakdown of, any mechanical, electrical, equipment, and goods within the property.
- The guests are not entitled to any compensation for failure of equipment or services.
- The guests are responsible for keeping the villa clean and all the facilities and equipment in good order.

### Pets

No pets may be taken into the villa.

### Smoking

We ask you not to smoke in the villa. We are non smokers, and do not wish the villa to be left with the remnants of smoke for us or any other persons who will use it. Please therefore smoke outside the property ensuring that cigarettes etc., are fully extinguished and any debris removed with the household refuse.

### Property Ownership

We as Owners of the villa reserve the right of access to the villa at any reasonable time during the holiday occupancy by either our local representatives, appointed tradesperson or ourselves. The villa is subject to the conditions and regulations by us and applicable to local and International Law. Neither we as Owners, or our local representatives shall be responsible for the death of or personal injury to you or any other person or loss, damage or accident to personal property save insofar as this results from our proven negligence.

- After departure an inspection will be carried out. The property must be left clean and tidy including the cooker, fridge and other equipment including the barbecue. All rubbish must be removed from the property on departure, public bins are situated on the route back to Colmenar village.
- Cost of minor damage to the property or contents will be deducted without prejudice from the deposit. Major damage claims will be dealt with by separate action. The owners will accept minor damages being replaced by the guests with the "exact match" or the approximate cash equivalent being left with our representative.
- The £200 Breakage/Damage Deposit will be posted within seven days of the Finish Holiday Date subject to any damage claim.
- This contract and all matters arising out of it are governed by English Law and are subject to exclusive jurisdiction of the Courts of England and Wales.
